## Glossary of Terms

- ‘The Owner’ is Fermanagh Lodges Hot Tub Hire.
- ‘The Hirer’ is you as specified below.
- ‘Equipment’ includes all hot tubs, accessories and other hire equipment that the owner agreed to hire to the hirer.

## Extent of Contract and Title

- The owner will retain the title and ownership of the equipment.
- No conditions or warranties other than specified herein shall be implied or deemed to be incorporated to form part of the contract.

## Suitability and Delivery in Good Order

- The Equipment shall be deemed to be in good order and in accordance with the Hirer’s satisfaction unless notification is received by the Owner on the day of delivery.
- No warranty is given that the Equipment is suitable for the purposes of the hirer.

## Bookings

- We have received your security deposit for the hire period.
- The booking becomes binding once Fermanagh Lodges Hot Tub Hire has confirmed the dates of your hire period.

## We require the following;

- Full payment of at the point of booking.
- £100 deposit which is refundable on visual inspection of the hot tub at the end of hire.

- Confirmation of acceptance of these Contract Terms and Conditions to confirm that you have accepted Fermanagh Lodges Hot Tub Hire terms and conditions.
- Signed Hot Tub Declaration of Hire

## Security

- The Hirer shall be responsible for ensuring the security of the equipment at all times. Any costs arising from the Equipment not being secured are chargeable to the Hirer.

## Security deposit

- Your returnable deposit of £100 is required prior to delivery/installation. The rental charge for equipment is paid in full prior to the day of installation.
- The security deposit only covers light damage, small breakages or extra cleaning that may be required, you may be required to pay a higher security deposit if Fermanagh Lodges Hot Tub Hire believes the equipment is at a level of risk.
- The security deposit will be returned within seven days of uplift, minus deductions if applicable, which will be fully itemised.

## Cancellation

- Cancellation of less than 48 hours to installation will forfeit 100% of the booking charge

## Hot Tub and equipment usage

- You are responsible for any damage and loss caused to the equipment regardless of culpability during the hire period as stated on the booking form.
- Should the security deposit amount (£GBP) be insufficient to cover costs incurred to Fermanagh Lodges Hot Tub Hire, you agree to pay, in full, all costs to rectify this.
- No naked flames are permitted inside or within 1 metre of our hot tubs.
- No dogs or other animals are allowed inside our hot tubs.
- You agree that Fermanagh Lodges Hot Tub Hire accept no liability for any personal injury or damage to any persons or property suffered during the period of your usage.

- If you have any issue with our hot tubs or equipment during your hire, please contact Fermanagh Lodges Hot Tub Hire immediately using the contact details supplied to you.

### Termination

- The Owner will be entitled to terminate the agreement and remove the Equipment in the event of failure by the Hirer to comply with the terms and conditions of hire.
- The Hirer will ensure that all Equipment and accessories are returned in good and clean condition at the end of the hire period.

### Loss and Damage

- The owner accepts no liability or responsibility due to or arising from the Equipment becoming unusable through any cause whatsoever whilst in the care of the Hirer, except through the Owners negligence.
- The Hirer will be charged for any damage caused to the Equipment whilst in the Hirers possession.
- If the Equipment is not returned or significantly damaged, the Hirer will be charged for the replacement cost of the Equipment including the calculated daily rate of hire until the equipment is replaced.

### Finally

- We reserve the right to amend our terms and conditions at any time, without prior notice.
- We reserve the right to hold certain information about you (in accordance with the Data Protection Act 1998) for the following purposes: a. To send updates regarding the status of your orders b. To send newsletters and details of offers and promotions in which we believe you will be interested.
- Your details will not be shared with 3rd parties.
